Selling shareholders are authorized by to sign this Share Purchase Agreement (SPA).

(The selling shareholders and the Acquirer are hereinafter referred to individually as a "Party" and collectively as the "Parties")

WHEREAS

The selling shareholders are the legal and beneficial owners of 90,00,000 fully paid-up equity shares having face value of ₹ 10/- (Rupees Ten Only) each (hereinafter referred to as "Equity Shares"), representing 100% of the Equity Share capital and voting rights capital in M/s. Cultureantique Jewellery Private Limited (hereinafter referred to as "CJPL" or "Cultureantique" or "Target Company" having its registered office at 4th. F. 413, Ten-11, NR. Union Bank, C.G. Road, Navrangpura, Ahmedabad - 380009, the entire Equity Shares are hereinafter referred to as "Sale Equity Shares", the full particulars of which are set out in Schedule I hereto;

- (1) The Target Company was incorporated under the provisions of the Companies Act, 2013 and is registered with Registrar of Companies (ROC) in the state of Gujarat and having Company Identification Number (CIN) U36999GJ2021PTC123576.
- (2) The Transferor shareholders are not prohibited by any Government authority for dealing in securities and to the best of their knowledge and information, the Transferee shareholders, do not require any kind of approvals from any banks, financial institutions or any other authorities for dealing with the Sale Equity Shares;
- (3) The Acquirer is desirous of acquiring the controlling equity stake in the target company. The Transferor shareholders and the Acquirer after negotiating the terms and conditions of Sale Equity Shares have now reached the following arrangement, agreement, and understanding on the sale, scope and management of the proposed sale (for the sake of brevity referred to as the "Sale") and are desirous of reducing the terms of their understanding to writing;

ARTICLE 1: DEFINITIONS AND INTERPRETATIONS

1.1. In this Agreement (including in the Recital hereof), the following words and expressions shall, unless the context otherwise requires, have the following meaning:

- a) "Agreement" means this Share Purchase Agreement ("SPA") including all Schedules hereto as may be amended from time to time in accordance with its terms;
- b) "Approvals" means all authorizations, consents, approvals and permissions required under the laws of the Republic of India for or in respect of this Agreement including for performance of any obligation or exercise of any right by a Party;
- c) "Arbitration Act" means the (Indian) Arbitration and Conciliation Act, 1996, as now enacted or as the same may from time to time be amended, re-enacted or replaced;
- d) "Board" means the Board of Directors of the Target Company;
- e) "Claim" means any claim, demand, action, cause of action, suit, litigation, damage, loss, costs, liability or expense including, reasonable legal fees, professional fees and all costs incurred in pursuing any of the foregoing or proceedings;
- f) "Effective Date" shall mean the date of execution of this Agreement;
- g) "Equity Shares" means equity shares of Target Company having face value of ₹10/- (Indian Rupees ten only) each;
- h) "Purchase Price" has the meaning assigned to it in Article 3
- i) "ROC" means "Registrar of Companies", ROC Ahmedabad;
- j) "Sale Equity Shares" shall mean entire shareholding offered herein above by Transferor shareholders for sale to Acquirer & has also been assigned the meaning to it in Recital (1) above;
- k) "Target Company" or "CJPL" means "M/s Cultureantique Jewellery Private Limited" a company incorporated and registered under the provisions of the Companies Act, 1956, having its Registered Office at 4th. F. 413, Ten-11, NR. Union Bank, C.G. Road, Navrangpura, Ahmedabad - 380009.

1.2. Headings to Articles are for the sake of convenience only and shall not form part of the operative provisions of this Agreement;

1.3. References to Recitals, Clauses, Sub-clauses, and Schedules, unless the context otherwise requires, are to recitals, clauses, sub-clauses and schedules of, this Agreement;

1.4. References to a paragraph is to a paragraph of the Clause or Sub-clause in which such reference appears.

ARTICLE 2: SALE AND PURCHASE

2.1. Subject to the other provisions of this Agreement and against the payment of the sale consideration and other necessary compliances by the Acquirer, the Transferee shareholders, shall sell, transfer, convey, and deliver to the Acquirer and the Acquirer shall purchase and acquire from the Transferee shareholders, Equity Shares free from all liens, encumbrances, all rights, title, and interests of the Transferee shareholders in the Equity Shares together with all accrued benefits, rights, and obligations attaching thereto;

2.2. It is specifically agreed that the sale contemplated in this Agreement is for the whole of Sale Equity Shares and under no circumstances, the selling shareholders will be entitled to Offer, or the Acquirer would be entitled to claim pro-rata Equity Shares.

The Selling shareholders confirm that the Sale Equity Shares are fully paid-up and are free from lock-in or any lien whatsoever and other encumbrances and the Selling shareholders shall hand over the said confirmation letter to the Acquirer along with the letter received from the Target Company;

ARTICLE 3: VALUATION OF TARGET COMPANY, PURCHASE PRICE AND PAYMENT

- 31 First party has valued the Target Company at the enterprise valuation of its business at Rs. 90,00,00,000/- (Rupees Ninety Crores Only) and the Target Company has accepted such valuation. upon which the First party has expressed its willingness to acquire 100% of the shareholdings of the transferee shareholders, herein after referred to as the "transaction"
- 32 With such understanding and enterprise valuation, the Acquirer agreed to purchase 100% of the equity stake of Target Company held by the transferor and the transferors collectively agreed to sell their shareholding in the Target Company for valuable consideration to the Purchaser for an amount of Rs. 90,00,00,000/- (Rupees Ninety Crores Only) (the "Purchase"), as outlined herein.
- 33 That the Party of the First Part shall acquire 100% equity stake of the Target Company from the selling shareholders and the total purchase consideration of Rs. 90,00,00,000/- (Rupees Ninety Crores Only) shall be paid by way of issue of 9,00,00,000 (Nine Crore) equity shares of First Party at a price of Rs. 10/- (Rs. Ten Only). The first party shall obtain all necessary approvals from BSE and other authorities for such issue of shares.
- 34 The aggregate purchase consideration for the Sale of Equity Shares is Rs. 90,00,00,000/- (Rupees Ninety Crores Only) shall be discharge by way of issue of Equity shares by the Acquirer, the full particulars of which are set out in **Schedule II** hereto, as to the selling shareholders (the payment and receipt whereof the selling shareholders hereby admit and acknowledge) at the time of signing/Execution of this Share Purchase Agreement (SPA) and shall be subject to delivery of Sale Equity Shares by Transferor shareholders to the Acquirer, as stated herein above.
- 35 The Transferee shareholders shall sell, convey, and transfer to the Acquirer and the Acquirer shall purchase, acquire and accept from the Transferee shareholders the above-mentioned Sale Equity Shares at and for the Purchase Price (as defined above);

ARTICLE 4: EFFECTIVE DATE

- 41 This Agreement shall take effect from the Effective Date provided that the acquirer fulfills all conditions as stated in Article 3 above.

ARTICLE 5: CLOSING

- 51 **Acquirer's obligations at the Closing:** At the Closing, the Acquirer shall do the following:
- Ensure that the discharge of total Purchase Consideration by way of issue of equity shares of the Acquirer to the selling shareholders as provided in clause 3 subject to condition precedents fulfilled by the selling shareholders.
 - Provide a certified copy of a Board resolution authorizing the purchase of the Business and execution and performance of this Agreement, the Ancillary Agreements; and
 - Execute the agreements/ documents specified.

ARTICLE 6: REPRESENTATIONS AND WARRANTIES

The Parties hereby represents and warrant that in terms hereinafter listed (the "Warranties"), and agree and acknowledge that they are entering into this Agreement in reliance on such Warranties. Notwithstanding any provisions to the contrary, the Warranties and indemnification obligations shall remain in full force and effect.

- 6.1 The Acquirer warrants that the execution of this Agreement and the purchase of the Sale Equity Shares pursuant hereto, has been duly authorized and constitutes a legal, valid and binding obligation of the Acquirer enforceable in accordance with its terms;
- 6.2 That it is clearly understood between the parties that it will be the responsibility of the Acquirer to comply with the provisions of the applicable laws and obtain necessary approvals wherever required.
- 6.3 The Transferor shareholders warrant that they have the requisite power and authority to execute and deliver this Agreement and perform its obligations as set forth in this Agreement and that it is binding on the transferor shareholders
- 6.4 The Parties represent and warrant that neither the execution of this Agreement nor performance of their respective obligations hereunder, nor the transactions contemplated herein, nor the completion of the transaction envisaged herein, nor compliance with the terms and conditions of this Agreement will:
- 6.4.1 Contravene any provision of any law or any statute or decree, rule or regulation binding upon the Parties; or
- 6.4.2 Conflict with or result in any breach of any terms, covenants, conditions or provisions of or constitute a default of any agreement or instrument to which either is a Party.
- 6.5 The Transferor shareholders warrant that they are the legal and beneficial owners of all rights and interest in the Sale Equity Shares and that the Transferor shareholders have clear, absolute and marketable rights, title and interest in and to the Sale Equity Shares and that the Sale Equity Shares are free from and clear of any encumbrances, restrictions of any kind whatsoever and has not been transferred, sold, mortgaged or otherwise dealt with in favor of any person(s);
- 6.6 Transferor shareholders further warrant:
- 6.6.1 That there are no claims, disputes, defaults, obligations in respect of Income tax, Wealth tax, Customs, sales tax, Service Tax, TDS, Property Tax, Urban Land Tax or any other tax, levies, dues or cess or any non-compliances of SEBI/FEMA/Registrar of Companies/ Stock Exchanges relating to the Target Company of the previous years.
- 6.6.2 That there is no petition for winding up filed against the Target Company nor is any winding up proceedings being threatened to be initiated against the Target Company;
- 6.6.3 Transferee shareholders and the company shall indemnify and hold the acquirers harmless from any loss, damage, or liability arising from any breach of these obligations.
- 6.6.4 The Acquirer shall indemnify and hold the Transferee shareholders s harmless from any loss, damage, or liability arising from any breach of these obligations.

6.6.5 Transferee shareholders agrees to take responsibility for any liabilities that may have arisen before the signing of the SPA, and also indemnifies the acquirer from any liabilities that may arise in the future, relating to the period up to the date of this Agreement;

6.6.6 Simultaneously, the acquirer agrees to take responsibility for any liabilities that may arise after the signing of the SPA, and also indemnifies the Transferee shareholders and the target company from any liabilities that may arise in the future, relating to the period up to the date of this Agreement.

ARTICLE 7 - ACQUIRER WARRANTIES:

7.1 That the Acquirer have the necessary resources and authority to pay the required consideration under this Agreement;

7.2 The Acquirer warrants that he and his heirs, appointed intermediaries and attorneys shall ensure the completion of the acquisition process in all respects.

The Acquirer agrees and acknowledges that:

(a) None of the Transferor shareholders, their affiliates or their respective representatives, are making or have made any representations or warranties of any sort to or for the benefit of Acquirer, whether oral or written or express or implied, including any implied representation or warranty as to condition, merchantability, compliance with law, usage, suitability or fitness for any particular purpose,

(b) The Transferor shareholders expressly disclaim any other representations and warranties and all liability and responsibility for any other representation, warranty, projection, forecast, statement or information made, communicated or furnished (orally or in writing) to acquirer, its affiliates or their respective representatives (including any opinion, information, projection or advice that may have been or may be provided to Acquirer by any representative of either Transferee shareholders or any of their respective affiliates), and

(c) The sale of the Equity Shares as provided for herein is made on an "as is and where is" state without representation and warranty and without reliance on any information provided to Acquirer by the Transferor shareholders. For the avoidance of doubt the Acquirer accepts the Business and Equity Shares in the legal and fiscal condition that it is in with all legal limitations and the Transferor shareholders shall not be required to provide and shall not be deemed to have provided any (implicit) representation or warranty in respect of any aspect of Shares, other than the Transferor shareholders and warranties set out in Section 7 above.

ARTICLE 8: MISCELLANEOUS

8.1 **Waiver:** The terms of this Agreement may be changed, waived, discharged or terminated only by an instrument in writing signed by the Parties hereto. Waiver of any term of this Agreement shall not be deemed to be a waiver of any subsequent breach of such term or any other term of this Agreement. The failure of any Party hereto to claim default of any part of this Agreement, or any failure to enforce any of its rights hereunder shall not be deemed a waiver of any subsequent claims or rights under this Agreement;

8.2 Except as otherwise provided in this Agreement, each Party shall bear its own expenses relating to this Agreement and the performance thereof;

8.3 Each party hereto will take steps to duly perform and fulfill its obligations under this Agreement and extend full co-operation and assistance to the other Parties, as the other Parties may reasonably require, for giving full effect to the provisions of this Agreement;

8.4 **Time Limit and Extensions:** Any date or period as set out in this SPA may be extended with the written consent of the parties, failing which time shall be of the essence;

8.5 **Public Announcements:** At all times at or before the Closing Date, the Acquirer shall not issue or make any reports, statements or releases to the public or generally to the customers, suppliers or other Persons to whom the Transferee shareholders provides services or with whom the Transferee shareholders otherwise has significant business relationships with respect to this Agreement or the transactions contemplated hereby without the consent of the Transferor shareholders. The Transferor shareholders and the Acquirer shall also obtain the other Party's prior approval of any press release to be issued immediately following the Closing Date announcing the consummation of the transactions contemplated by this Agreement save and except as required under applicable law.

ARTICLE: 9 DISPUTE RESOLUTION

9.1 For the purposes of this Article, Transferor shareholders shall be considered as one Party.

9.2 **Initiation of proceedings:** All the dispute arising in connection with this Agreement shall, to the extent possible, be settled amicably by prompt good faith negotiations between the representatives of the parties. In default of such amicable settlement within thirty days (or such period as agreed between the parties) of the commencement of discussions, the dispute shall be finally settled by an Arbitrator appointed under the Indian Arbitration and Conciliation Act, 1996;

9.3 **Venue, Language and Number of Arbitrators:** Arbitration shall be held at Ahmedabad, India, in the English language. The arbitrators shall decide any such dispute strictly in accordance with the governing laws prevailing in India. The arbitration shall be conducted by a sole arbitrator to be mutually agreed. In the event the parties are unable to agree to an arbitrator within 10 days of notice as contemplated above, the party seeking arbitration will be at liberty to apply to the Competent Court/Designate Authority for appointment of the sole arbitrator in accordance with the Arbitration and Conciliation Act.

9.4 **Finality of Award:** The award made by the Arbitrator shall be final and binding between the parties;
